Minutes of meeting 28/8/95. Discussion re condition of court 10. David queried socks as part of dress code. Dennis felt dress standards should apply for all competitions - not just Saturday.

LADIES MIDWEEK REPORT: Pat Healy queried status of Sue Singleton's proposal for children's play area. Pat was advised that the proposal had been given to the Ladies Midweek committee for their recommendations. No recommendations had been received from LMW.

Pat also advised that the hot water urn was still dangerous and requested that it be modified to avoid anyone being hurt.

JUNIOR SUBCOMMITTEE REPORT: Last meeting was 20/7/95. Dennis advised that Neil Packer had resigned but would be coming back. Outside courts being booked for the Champion of Champions.

GROUNDS & FINANCIAL MANAGEMENT REPORT: No meetings have been held recently. Dennis reported on "shade" meeting with Brian Healy and Steve Guest. They will be spending approximately \$4000 on shade structure above court 10.

GENERAL BUSINESS:

Steve then reported on the Brisbane Water Open. There have been approximately 115 entries (approx 95 people). Discussion followed as to whether or not tournament should go ahead. Decision to hold off until Saturday to make decision to see if more entries are received. Megan asked if Social subcommittee should run BBQ and was advised to wait until Saturday to see if tournament was going to go ahead.
