COMPETITION SUBCOMMITTEE REPORT: Steve expressed concern at a player (Chris Lowe) playing in team more than 2 divisions from his last grading. Discussion followed.

Mavis queried reasons behind renumbering of Sat Mixed divisions.

Query from Tony re how long must teams be playing (Night Comps) before court hire is due (wet weather). Discussion followed. Entries close at the end of March therefore Jr s/comm will be looking for i/dist teams.
