Matters discussed as per Agenda

1. Pro-Shop/Canteen Agreement

A lengthy discussion was held with Phyllis and David Graham.

As the Option was not taken up by due date we will continue on a month to month basis, at present rates, until the Council finalises our leases and we will then advertise for "Expressions of interest". It was pointed out that G.D.T.A. were not asking Phyliss and David to leave, and they are welcome to submit a tender, which would be given serious consideration.

We hope to have leases finalised earlier than June, and Mavis will notify the Grahams as soon as possible as to when we are ready to continue our discussions on this matter.

2. Lease for Association

Council requested \$12,000 as a lease figure. We are still continuing negotiations to have this decreased. Mavis has discussed this matter with Council on 3 occasions. The Recreation Department have agreed to submit to the Legal Department to have this figure reduced. They are considering a reduction and would like to discuss this matter further. Mavis and Murray will arrange a meeting to endeavour to finalise this matter to our satisfaction. It appears they will write the figure at possibly \$12,000, however will then give us a Grant back which would be used towards capital improvements.

3. Letter re Parking Area Bottom Courts
