TENNIS COMMITTEE REPORT:

Anne tabled letter received from Peter White re team "Moir or Less" in Thursday Night Comp. Jennifer will reply that letter was tabled, but decision of Committee will stand.

Carolyn Perryman cannot play in semi-final, replacement approved.

Thursday Competition. Semi-final 1st division was played a week before 2nd semi-final. On semi-final night, 3 of the 1st division teams could not field a team. An Executive decision was made that it would be transferred to the following week. GTC complained they were not informed and it was going to cost them money. Hal spoke with Rod & Jenny on Saturday re this and the problem resolved.

Semi-finals will now be tomorrow night and Division 2 will be "First past the Post".

JUNIOR REPORT:

Hal addressed the Meeting. He put forward a nomination of Maureen Rowe as Chairperson of Junior Committee and Maralyn Brooks as Competition Secretary for Junior Badge. Maralyn will put entries into teams for discussion by the Junior Committee, check cards, scores, etc.

Reserves will be handled by GTC.

Hal advised that during the Junior Championships recently, some players who were unregistered were allowed to play and in at least 2 instances, these unfinancial players reached the Finals which caused comments from some parents whose kids were financial and were "put out" by the unfinancial kids. No unfinancial player is to start in any match – NO EXCEPTIONS. If any Committee person allows anyone on the court who is not financial, the President will be put in the position of asking the Committee person to leave the Committee.

Also, once dates are set for any Championship events they must not be changed or extended. The only exceptions to a time draw will be made in the case of players involved in State, Regional events and the like. If players are not available for match at time of draw, they will have to forfeit. This will have to be ponted out at time of entry. Any change to time draw must be referred to Committee.

Also, anyone who enters an event after seedings are done, will not be considered for seeding and will only be added to the event if it is possible to fit in with the draw.

Hal advised we have to adhere to the rules.

SQUAD nominations - Hal will provide the list of these nominations.

In relation to the letter written by Patrick King, meeting agreed that Hal will speak with Patrick personally next Tuesday.

L.M.W. report given by Rosie Leggatt.

Rosie will advise their meeting tomorrow the request for volunteers for Addidas. L.M.W. to be advised that under no circumstances are unfinancial members to take court.

L.M.W. to be requested to share half cost of account for hand dryers. Hal pointed out that Health Department would require them.
