Prior to forwarding letter, Maureen spoke with Warren Roberts. (20/7/06). He advised that has some good news, he has had a meeting with the grass manufacturers and they have agreed to replace the grass.

In relation to costs for actual work, Major Sports can retain the grass (which manufacturers claim has 10 yrs life, just colour that is a problem) and sell it to recoup some of the cost.

We have now received a faxed letter from Major Sports confirming their verbal advices that the grass manufacturer will replace grass leaving Major Sports to foot the bill for labour, etc.

In view of their long association with GDTA they are prepared to do this and will keep the grass.

At this stage, due to him not yet being able to return to work, they are unable to give a time frame on doing this work.

Discussed perhaps laying this grass on court 14, however meeting feel it may not be successful and would rather wait and see how we go with the Grant as it would then be of no use to us as a grass court. Major Sports gave a quote of \$6,250.00 to do this work should we wish to do so.

Steve advised Membership cards to be posted within next week.
