## **Finance Committee Report**

Peter, thanks for hosting today and apologies to Steve again for omitting him on the initial invite.

Here is a summary of what we discussed, and if I have anything incorrect please let the audience know:

- 1. **Peter's current numbers** we are close to break even, approx. \$400 short a month. Cash flow to improve by upfront term payments due week starting 30/4 which hopefully will get us through until Memberships flow in from 1 July.
- 2. **Final numbers to March 2018** Nick should be able to provide this by next committee meeting which is a super effort. Nick and Jackie are still working through some outstanding items, but these should be finalised soon.
- 3. Infrastructure Grant Nick commencing the application due on 4 May. We discussed a grant of roughly \$400k to cover a possible new water connection to the top site, resurfacing and lighting of lower complex and replacement of existing lights with LED's on top complex. With any money left over we would be seeking funding to cover disability access/toilets for both complexes. I will forward letters to Lucy Wicks, Taylor Martin, Liesl Tiesch, and Adam Crouch advising that we have applied once Nick gives the thumbs up.
- 4. Membership Fees to be recommended at Committee level Adults \$40, Seniors \$20.00, Juniors not playing in Blue, Red and Orange Ball \$20, Juniors playing in Blue, Red & Orange Free, Family consists of 4 persons minimum and receives an overall discount of 25% on full priced individual memberships. Social players \$15. Membership period 1/7/18 to 30/6/19. Membership to include Free Sunday Play, Free Off-peak Play, 5% discount on all products, able to play organised competitions, club championships and represent your club. We will need to get a membership scanner and organise cards to be printed.

- 5. **Court-Hire** \$5 per person per hour for the day and night court hire plus a \$10 per hour night level
- Pay Rates Tony to issue updated pay rates and further discussion to place Bonny and Tom on Permanent Part-Time due to reduced hourly costs, and hours they are working at present.
- 7. **School Holiday Camps** numbers are down, and it is likely the best-case scenario is break even over the 9-day holiday term.
- 8. **Potential Insolvency Issue** should Rob's request be successful for unfair dismissal; the club will likely go into insolvency. We have received a further bill (\$1435.83) that hasn't been paid for 12 months served at last Sunday's volunteer day. This is on top of the Security bill we haven't paid for 12 months which I have yet to get the bill however was advised it would be sent shortly. I will provide this bill for payment to Jackie.
- 9. NSW Tennis Regional Office an offer has been made via Maurice Murphy to relocate the Tennis NSW office from Tuggerah to the Committee room located on site. The proposal in lieu of rent is to waive the affiliation fees of approx. \$6550 and a contribution from TNSW of \$150 per month to pay for outgoings. We have agreed to take this to the next committee meeting for feedback.
