- Motion To approve the sum of \$3,850 + \$2,200 (incl) for survey and master plan and \$510 (incl) on video to support Master Plan Total \$6,560 all in favour

## 6) Business Arising:

Budget of \$32,000 for LED's, Courts 8&9 - LED \$25,000, Use cheery picker to replace light on court 2, Court resurfacing 2 courts by 2 coast (approx \$14,00).

  on court 2. Look at cost for repairs to courts in preparation for Platinum event. Executive to subsequently
  approve the spend of this money. Total costing approx \$30,000 (less rebate) All agreed
