

Court booking participation is based on 2 players taking up 1 court booking. In term 3 we have local schools booked in including CCGS booking 4 Saturday mornings to play their inter-school competition. Our competitions are holding their own despite it being winter, and full coaching returns from Term 3. It is noted that for the school camp held last week we had booked out at 64 players per day, a record, and a promising start to Term 3 coaching.

UTR hit-ups have significantly reduced due to lockdown restrictions easing and he recommencement of the Super Series, which is now seeing 50 players participating each Saturday, of which 20% are travelling from Sydney. Ladies Mid-week have only just returned and will be fully in operation during term 3.

All in all, we should see increased average participation numbers in term 3.

Court Bookings



Our court bookings are averaging 63 per week for the past 14 weeks during term 2, down from a peak of 92 which was recorded during COVID lock downs.

3. Pro-Shop, Café & Catering & Gym

Jackie has reported the following is now in place or remain a work in progress:

- <u>All Honour Boards</u> completed, and the main club house room looks fantastic. We are starting to see people look at the boards which is great news.
- Aussie Signs will be installing signage on the pro-shop wall and a new sign at the front gate advertising our products and times of opening.
- <u>Acrylic holders</u> the new wall signage has been installed and then the acrylic holders will be secured with information brochures.
- New POS System called "IN Tennis" is now in place and helping us to record attendances for each coaching program and tennis product we sell.
- Merchant facility change this is now in place called Tyro

We have now added Hugh Littlefield to the staff, and he will take over from Dylan once he moves to the USA early next year for college.

4. Competitions (Products)

- We have a record 8 teams for Sydney Inter-district which commences on 26 July. All players are being decked out with player shirts and we have some strong teams playing.
- Our super series is now making solid profits after all costs and prizemoney with 50 players in attendance on a regular week.
- Night competitions are going well despite the cold weather with average numbers around 12 on Monday night, 18 on Tuesday night and 16 on Thursday night. The new LED lighting and upcoming warmer weather should see these comps expand.
- We are to introduce a new Friday Seniors comp for over 50's and re-commencing Sunday Social in the afternoons.

5. UTR

- I have now introduced a separate report for UTR which has become a game changer for the club in increasing participation. When we first started, we had 55 registered UTR players and we now have 282. This is a larger number then Ta or TNSW have at present.
- Interestingly, we have created a separate membership via UTR registration which ranks all players and is an opportunity for us to market separately through this base as we are creating an email list of advertising our local competitions.

6. Membership

- Membership Numbers for the 2019/20 year was 1405 which is a 56% increase on last year, an excellent result. We now have 320 paid members from 1 July 2020.

- 8. **Social Media** for the month 20/6 to 17/7, a summary of our Facebook page showed:
 - 1253 people who like our page up by 1.4% on last report.
 - 926 post engagements, up 89% and we reached 1,299, up 338 from previous month.
